Requirements of fund transfers for Overseas Pensioner's Accounts

To Overseas Bank accounts :

- Permanent Residency details required such as Permanent Resident card/ Visa Documents/ Permanent Resident Certificate/Copy of Foreign Passport
- Maximum limit Rs. 500,000/-
- Beneficiary account must be an individual savings bank account of a foreign bank under the pensioner's name.
- Form No 1- Sale of Foreign Exchange must be sent along with the request.

To Bank of Ceylon another account of Pensioner

• Beneficiary account must be an individual savings bank account of another branch of the Bank of Ceylon maintained under the pensioner's name.

Life Certificate

- Life certificate can be certified by any professional (Eg.Attorney,Solicitor, Doctor etc.) with the official stamp/seal
- Should send fresh Life Certificate with each and every fund transfer request.

Following conditions are also applied

- Fax and e-mail requests are not accepted.
- Third party transfers are not allowed.
- Power of Attorney is not accepted.
- Automatically transfers/standing orders are not accepted.
- ATM Cards are not issued.
- If you are unable to sign properly due to medical conditions your left thumb impression can be placed which should be witnessed by a doctor. The doctor must confirm in writing that "The pensioner is in sound mind, this is the true thumb impression of the pensioner and placed the thumb impression in her/his presence.
