### **PROCUREMENT NO: ENG/ALC/RFP/22/030-1 & ENG/ALC/RFP/22/030-2 REQUEST FOR PROPOSALS FOR THE OPERATING LEASE OF FIVE (5) NARROW-BODY AND FIVE (5) WIDE-BODY AIRCRAFT BY SRILANKAN AIRLINES LIMITED (SLA)**

Bids are invited by the Chairman of the Standing Cabinet Appointed Procurement Committee, of the Ministry of Ports, Shipping and Aviation on behalf of SriLankan Airlines for supply of suitable Aircraft, from eligible and qualified bidders, on operating lease basis, as defined in the respective 'REQUEST FOR PROPOSAL (RFP)' which can be found at SLA's official website

([https://www.srilankan.com/en\\_uk/corporate/tender-notices](https://www.srilankan.com/en_uk/corporate/tender-notices)) from 19<sup>th</sup> December 2022.

Bidding will be conducted according to the Procurement Guidelines of Government of Sri Lanka through International Competitive Bidding (ICB) procurement method. All interested eligible bidders who possess legal rights to lease potential Aircraft, may submit their bids via e-mail to the secured e-mail address [asset@srilankan.com](mailto:asset@srilankan.com), indicating the RFP reference as applicable (ENG/ALC/RFP/22/030-1 or ENG/ALC/RFP/22/030-2) by 1400hrs Sri Lanka time (GMT + 0530) on 30<sup>th</sup> January 2023 (the deadline for the submission of bids).

The bids shall contain the following requisite documents in order to be considered eligible.

- Profile of the Bidder
- Authorization from the owner of the Aircraft for the Bidder to submit bid to lease the Aircraft and assurance that the owner agrees to enter into a lease agreement with SLA on the terms submitted by the Bidder.
- Information relating to existing financial arrangements/ mortgage/liens on the Aircraft (whether the Aircraft is under a mortgage etc.)
