Triple Super Phosphate for Maha Season 2022/23

Procurement Method: International Competitive Bidding (ICB).

01. The Chairman, Standing Cabinet Appointed Procurement Committee (SCAPC) on behalf of the Ministry of Agriculture and two state fertilizer companies of the Ceylon Fertilizer Co. Ltd. and the Colombo Commercial Fertilizers Ltd., invites sealed bids from eligible TSP manufactures, suppliers or their accredited agents for the supply of the Triple Super Phosphate for the paddy cultivation of the Maha season 2022/23 commencing **15th of September 2022**.

Triple Supper Phosphate (TSP) - 36,000 Mt

02. Minimum lot size should be 18,000 Mt for bulk or bagged cargo.
03. Lot numbers expected minimum lot size, mode of shipment and arrival / destination port as follows.

Lot	Quantity (Mt)	Mode of shipment	Destination Port
Lot A	18,000	Bulk / Bagged	Colombo
Lot B	18,000	Bulk / Bagged	Colombo

04. Eligible bidder should satisfy following requirements;
- Registered as a business with the appropriate authority in the respective country for a minimum period of two (02) years to the date of the submission of the bid.
 - An experience in the International Trading of Fertilizer, within the immediate past one (01) year to the date of the submission of the bid.
 - Minimum annual turnover of **US\$ 25 million** from the International Trading Business in the immediate preceding financial year.
05. Bidding documents available on **24th June 2022** in the website of Ministry of Agriculture, Sri Lanka (www.agrimin.gov.lk). Interested bidders can download bidding document from the above website.
06. Bidding will be conducted through International Competitive Bidding Procedure (ICB). However, it is decided to reduce the bidding period to **21 days** due to urgency of the requirement before commencing of the Paddy Cultivation of the Maha Season in 2022.

08. The Pre Bid meeting will be held on **04th July 2022** at **10.30 a.m** in the premises Conference Hall (01st Floor) of the **Ministry of Agriculture, No. 80/5, "Govijana Mandiraya", Rajamalwatta Lane, Battaramulla, Sri Lanka.**
09. Bids will be closed at **11.00 a.m.** on **14th July 2022** and opened immediately thereafter. Bidders or their authorized representatives are requested to be present at the bid opening. Late Bids will be returned and unopened.
10. All bids must be accompanied by a **Bid Security Guarantee (per Lot US\$ 198,000)** obtained from a commercial bank registered or accepted by the Central Bank of Sri Lanka.
